RARC Animal Social Housing & Enrichment Requirements (ASHER) for species other than nonhuman primates*

1) Social Housing Program

- a) Social housing will be applied according to this document.
- b) Social housing requirements in this document apply to animals used in biomedical protocols only. Agricultural animals are housed according to the *Guide for the Care and Use of Agricultural Animals in Research and Teaching* and industry standards.
- c) Housing strategies may differ from that described in this document if there is scientific justification and IACUC approval, or at RARC veterinary discretion.
- d) Individuals of a species may be incompatible for social housing, such as female hamsters and some intact adult males.
 - i. These animals may be permanently separated into single housing.
- e) Female rodents near the time of parturition may be singly housed to allow for recommended minimum space.
- f) There may be instances where there is only 1 individual animal present; e.g. 1 animal remaining in a group or study, or 1 animal ordered for a pilot study.
 - i. To prevent additional experimental variables (e.g. by the addition of a new animal to the pen/cage) these animals may be singly housed until the end of the experiment.
- g) Some species (e.g. 13-lined ground squirrels) are not considered social and will be housed individually.
- h) Additional Social Housing information may be found in School- or facility- specific Standard Operating Procedures.

2) Environment Enrichment

- a) Environmental Enrichment will be applied according to this document.
- b) Environmental Enrichment requirements in this document apply to animals used in biomedical protocols only. Agricultural animals are housed and maintained according to the *Guide for the Care and Use of Agricultural Animals in Research and Teaching* and industry standards.
- c) Environmental Enrichment strategies may differ from that described in this document if there is scientific justification and IACUC approval, or at RARC veterinary discretion.
- d) Additional Environmental Enrichment information may be found in School- or facility-specific Standard Operating Procedures.

3) IACUC Review

a) Each IACUC will review the Social Housing and Enrichment program on a regular basis.
